and local investors). MVIWATA has been very active in land rights matters, especially in partnership with Land Rights Research Institute (HAKIARDHI) who together with other 5 organisations have formed a Tanzania Land Alliance (TALA). Together, we have investigated human rights abuses in land issues, to push for bringing the perpetrators to justice; defence of evicted families as the case was in Mbigiri Village in Kilosa District; Itete Ulanga District. Through TALA, we have engaged legislators and the government in amending Land Act of 1999 and its recent by laws.

In partnership with Misereor MVIWATA has facilitated provision of customary titles to 727 persons (244women and 483 men) as a way of ensuring land security to the farmers.

In terms of trade advocacy, MVIWATA with other parts especially in Trade Coalition have worked hard to ask the government to look at the implications of Economic Partnership Agreements (EPAs) before signing, which happened to be a successful action.

In 2012, MVIWATA was awarded by Food, Agriculture and Natural Resources Policy Analysis Network (FANRPAN) FANRPAN, a movers and shakers award in recognition of policy advocacy work that MVIWATA has been doing.

Gender and HIV/AIDS: In terms of gender actions, the work of MVIWATA has gradually and systematically increased gender awareness amongst smallholder farmers paving the way for some women to participated more actively in development and economic activities. Training on leadership and exposure of farmers through gender programmes such as festivals has increased women engagement in economic activities. In Arusha for example, the intervention of MVIWATA Arusha has enabled women who are involved in handicrafts making to get a fair prices on their products by linking them to markets in Sweden in which about 260 women producers of handicrafts have been trading handicrafts of about Euro 155,500. In this way changing lives of rural families.

MVIWATA supported creation of social centres in Matai, Igurusi and Kasanga rural markets in which market users, especially farmers can access voulutantry counselling, care and treatment in which local organisations, namely SHIDEPHA and Olive Branch provide VCT services. 1500 persons ask Hasira are estimated to receive VCT services per vear from these three centres.

Market Access: For the last ten years MVIWATA embarked on promotion of rural markets infrastructures as a way of linking producers to markets in their production areas. The initiative has aimed at improving market conditions and accessibility of production areas by traders. Nine rural markets have been constructed through this initiative. Kibaigwa market on its own has contributed 665,493.00 tons of maize from 2004 to 2012 in worths T Shs 188,468,208,000.00 (about Euro 90m Euro 1=Tshs 2100). The markets constructed by have contributed substantially to feed the cities but also contributed in generating income to over 100,000 smallholder farmers around the markets. On the other side the markets have created huge economic impact in market locations increasing economic activities and therefore creating employment apart from contributing to the local government revenue. In 2013 alone Kongwa District Council collected T shs 329,404,055 as levy from Kibaigwa market.

Market information system: To address the challenges of is access to market information to smallholder farmers, since 2010, MVIWATA designed and gradually improved an agricultural marketing information system, abbreviated as (MAMIS) to smallholder farmers have made informed decisions basing on correct price information. Ever since the system has recorded about 73200 in 2012 and 2013 and benefitted not less than 15,000 persons which have used this information. The system has linked markets users covering 27 rural and urban consumer markets and has provided the service that was never available before. In 2013, 224 tons of maize worth 147,600,000/= were purchased through the system. The system has attracted not only market users but also many actors whoh have been attracted to learn how the system works.

Financial services: In terms of financial services, at least 100 smallholder savings and credit cooperatives and associations have been created and supported by MVIWATA in its endeavor to facilitate access to financial services to smallholder farmers in Tanzania. About 500,000 farmers per year are able to access loans of an average T.Shs 5 billion per year. By 2013, an average of T.Sh 10 billion loans have been given to 17,871 members half of whom are women. The loans have been used to transform lives of smallholder farmers by increasing their production and address social challenges such as school fees and medicines..

Food security: Over 10000 smallholder farmers have benefitted from the programmes to support agricultural production. Farmers which have undergone training in production have been able to increase their production and therefore have more food and income from the production. The food security has also been improved through the cereal banking systems in which at 4000 farmers are engaged in the system in Morogoro, Dodoma and Njombe regions to mention a few.

MVIWATA in a nutshell

Mtandao wa Vikundi vya Wakulima Tanzania (MVIWATA) is a farmers' organisation which unites small holder farmers in order to have a common voice in defence of economic, social, cultural and political interests of smallholder farmers. It is the National Network of Small-scale Farmers Groups in Tanzania.

MVIWATA was founded in 1993 by 22 innovative farmers from Morogoro, Iringa, Kilimanjaro, Mbeya, Rukwa and Dodoma regions for the purpose of creating a farmer-to-farmer exchange forum. Sokoine University of Agriculture (SUA) through its Strengthening Communication Project (SUA-SCOM) which guided the initial process in the formation of MVIWATA.

It was registered in 1995 under the Society Ordinance Act (Reg.no.SO8612), in 2000 as the Trust Fund. In 2007 MVIWATA received a compliance certificate under the NGO Act of 2002 (Reg.no 1930). The national office of MVIWATA is situated in Morogoro town.

Our Goal: To unite smallscale farmers (including all small holder producers, whose livelihood depend on land such as pastoralists and fisher folks) in order to defend their interests and address together the challenges of farmers.

Our mission: To strengthen farmers' groups and networks, facilitate communication and learning among farmers for the purpose of defending the interests of small scale farmers

Our vision: To become a strong national farmers' organisation that will guarantee small-scale farmers' participation

The slogan of MVIWATA is "Mtetezi wa Mkulima ni Mkulima Mwenyewe", literally means, "The defender of a farmer is a farmer!"

Objectives of MVIWATA

- 1. To facilitate communication among small scale farmers in order to build collective strtegies for defending farmers interests
- 2. To facilitate exchange of knowledge, experiences and skills on farming and activities which aim at improving the livelihood of farmers
- 3. To represent smallholder farmers in matters and decision making bodies of interests to small holder farmers

Strategies of MVIWATA

- 1. Organising farmers into strong groups and networks through, through which farmers attain common voice platforms to advocate for their interests.
- 2. Capacity building of small-scale farmers on lobbying and advocacy through training .
- 3. Economic empowrment of small scale farmers through creation of projects such as savings and credit, cereal banks, rural tourism and other rural entreprises
- 1. Affiliation with national and international networks and organisations for lobbying and advocacy purposes. These include La Via Campesina, the International Land Coalition (ILC), the Eastern and Southern African Farmers Forum (ESAFF), Eastern African Farmers Federation (EAFF), Participatory Ecological and Land Use Management network (PELUM)

Current programmes include the following;

Membership

MVIWATA has three types of membership

- b) individual farmer whose membership is acquired through the group. The farmer becomes a member of MVIWATA automatically after his/her group or network has been registered as a member.

Organisation, association and networkswhich are owned by small-sccale farmers and whose objectives are compliant with the mission of MVIWATA can be eligible for membership

Associate members

Is any person, institution or a group of people, who cannot become ordinary members but whose contribution can be outstanding and can enhance the mission of MVIWATA. Currently, MVIWATA has over 150,000 individual smallscale farmers through their groups

Achievements

Step by step MVIWATA has been building membership in all regions of Tanzania to reach at least 150,000 members and over 2 million beneficiaries of MVIWATA interventions. The groups and networks have participated in sustainable production, savings and credit activities, markets and social activities.

Advocacy work: MVIWATA has participated effectively in advocacy work on land, trade and markets, seeds protection and recently process on national constitution There has been increased engagement of farmers in national, regional and international policy issues. This has been attributed by the recognition of MVIWATA as a key player in national policies resulted in participation of MVIWATA representatives in committees and decisions making bodies in research
